TREASURER'S REPORT (Cyndee Paulus): Savings balance of \$15,001.73. Checking balance of \$11,298.84.

CORRESPONDENCE RECEIVED (Cindy Liebeck):

1. AKC: April sweepstakes approval notice received (previously received and forwarded as noted in December).
2. AKC: April events approval notice received and forwarded to Chairs Munt & Johnson.
3. Request for officer update to BCA (completed as was AKC update).
4. Bulldogger: Stud Dog Index being started. \$60 per issue for listing. Deadline of 2/1/16 for the next issue. Details will be in the next Bullpup.

COMMITTEE REPORTS

AKC Delegate (Link Newcomb) - December delegate meeting attended, electronic show media passed. Premium Lists, Judging Programs and Catalogs may now be all electronic. Exhibitors can request written documents. AKC puppy registrations up 1.5% through October. AKC revenues up 5%. There is a Director election in March.

AKC Education (Scott Johnson) - none

Auditing (Link Newcomb) - none

Open: approval of the audit committee report of the 2014 books distributed by Link Newcomb at the 10/14 meeting.

ACTION: Link to send Cindy electronic to have copies for the Board on Sunday.

BCA Update (Link Newcomb) - BCA Div III meeting held in Indio. Committees filled except legislation. October 1-2 are the dates of 3 BCNC shows. One Generic Division III show will be held on Sunday afternoon (October 2). \$1800 was raised at "Rubber Ducky" fundraiser. Div III donated \$5000 to BCNC to get started.

From Scott Johnson - Changes are being made to the traditional Ventura Summerfest event. BCA Div III specialty will be in conjunction with Ventura County Dog Fanciers and Burbank Kennel Club 6/30-7/3 at the Ventura County Fairgrounds at Seaside Park (where the event normally is but a week earlier). Bulldog City with show ring near the RV parking will be available as will the BBQ event. Summerfest name may change. Scott Johnson is working with representatives from the all breed clubs to finalize details.

Bullpup (Cindy Liebeck) - none

Breeder's Match & Futurity Event, October 2016 (Cyndee Paulus, Sherian Evans) - Two members have already filed their futurity applications.

Challenge Trophies (Renee Benjamin) - 2015 tallies are complete. Next month Renee will be requesting sponsors for trophies.

Champion Awards (Scott Johnson) - No applications have been submitted. Requirements for awards will

be revisited at the Board Planning meeting on Sunday.

Fun Match, Sanction B Match, March 2016 (TBD) - To be discussed on Sunday.

Membership (Debra Munt) - 45% of memberships received. Debra has received new member applications and will forward the information to Cindy Liebeck to publish in the Bullpup.

Social Media (Antonio Lemes) - Antonio thanks Sherry Webb for her help with FaceBook. Please send pictures to post to Antonio Lemes.

Specialty (Debra Munt) - Debra reported an issue making room reservations for Wednesday night due to another event at the hotel.

Rescue Committee (Debra Munt) - Several dogs placed over the week-end. 42 volunteers are working to help out, but more are needed.

Website (Sherry Webb) - Prizes for contests needed - discuss on Sunday.

Championship Award Rules

1. The recipient of the Champion Plaque must receive at least ten (10) points, including one (1) major in the following locations: San Luis Obispo County, Fresno County, Kern County, Tulare County, Kings County, all Southern California Counties, all shows put on by a Bulldog Specialty Club held in Division III, or the National Bulldog Specialty no matter where held.
2. All legal owners and co-owners of the dog **MUST** be members of Pacific Coast Bulldog Club, Inc. in good standing at the time the required ten (10) points, including one (1) major are earned.
3. Those who apply for a plaque and do not meet the requirements will receive a Championship Certificate. All members who finish a Champion in the United States, regardless of locality, are entitled to a Championship Certificate and may apply for only the certificate by checking the appropriate box.
4. The Championship Award Application can be obtained from the Championship Award Chairperson or the Bullpup Editor.
5. The completed application must be submitted with a copy of the AKC Championship Certificate, the AKC Registration Certificate, and a 8x10 colored show photo or a good quality colored photo copy of the new champion no later than December 31st of the year prior to the Specialty Show to the Championship Award Chairperson. The photo will be retained as part of the permanent records of the Pacific Coast Bulldog Club, Inc.
6. The first plaque per recipient is free. Additional plaques may be purchased at the time of application for \$50 (fifty dollars). Check the box at the bottom of the application form and enclose a check made out to PCBC with application and mail to the Championship Award Chairperson at the address below.
